- A new Restoration Manager, Alys Arenas, was hired and the restoration team expanded to include 4 positions.
- Volunteering and public programming was greatly impacted by the COVID-19 pandemic including the FiiN program.
- In response to the pandemic restrictions staff came up with multiple opportunities to connect virtually including increasing content on YouTube, opening an online gift shop and reimaging coastal cleanup day into a webinar about trash.
- The change in programming gave staff time to focus on administrative tasks including developing an online waiver for kayaking and outrigger events and revising the curriculum for our education events as well as Naturalist training.
- The book release was a big success with the 1st run completely selling out and a 2nd run being ordered.
- Raised \$6,000 at the online Back Bay Bash
- The Big Canyon phase 2A project reached all milestones on time and the Big Canyon Phase 2B/C is on track.
- Invasive plant eradication efforts continued focusing on ASL and volutaria.
- Naturalist Training hosted 19 students.
- The osprey nest perch was upgraded and a webcam installed.
- A new underwater life movie is being developed with spanish subtitles.
- Several improvement projects have made progress including updating the mud tunnel in the Muth center, improved signage and OCP trails and overlook.
- The World Wetlands Day event "Climate Solution Conference" was a huge success with 250 attendees.
- Working on getting RAMSAR designation.
